URBAN & COMMUNITY FORESTRY AWARDS OF EXCELLENCE

1. **Private Professional Award** - The Private Professional award, is given to an individual who works for a company whose business is related to urban forestry (arboriculture, horticulture, nursery, grounds manager, etc.). The award recognizes an individual who has made outstanding contributions to the urban forestry effort at the local, regional or state level.
2. **Green Industry Award** - The Green Industry award is given to a company or organization who shows leadership and dedication in advancing urban forestry efforts at the local, regional or state level.
3. **Media Award** - The Media award was given to an electronic or prints media entity that had made a significant contribution to trees and/or urban forestry in its area.
4. **Builder/Developer Award** - The Builder/Developer award is given to the company or corporation that has done an outstanding job of protecting and maintaining trees during the project construction process.
5. **Council Member Award** - (Discontinued) The Council Member award went to an individual who was a member of the TUFC who, through perseverance and perspiration, has accomplished major goals of the Council and thereby furthered and enhanced its efforts.
6. **Government Employee Award** - The Government Employee award recognizes an individual working for a government agency who has made outstanding contributions to the urban forestry effort at the local, regional or state level.
7. **Tree Board Award** - The Tree Board award is given to the local board or committee that has made outstanding accomplishments in completing urban forestry projects, provided exemplary leadership, and made significant progress in meeting the goals of their local urban forestry program.
8. **Citizen Activist Award** - The Citizen Activist award is given to an individual person not employed in a related Green Industry area who, through dedication, has made significant and outstanding contributions to urban forestry at the local, regional or state level.
